It can include additional benefits, such as making a voluntary internship in your entity/company. An additional fee of 500€ will be charged to compensate the organization for the effort of organizing it.
- Best poster prize. The prize will be named including your brand. Minimum 500€ that you should pay directly to the selected person by the members of the scientific and organizing committee (plus a representative of your entity). It can include additional benefits, such as making a voluntary internship in your entity/company. An additional fee of 300€ will be charged to compensate the organization for the effort of organizing it.
- Organization of an event for young researchers. Such an event will be announced during the registration. The event must be free of charge for the attendees and cannot be organized at the same time as other social events of the workshop.
